I am the same Timothy Johnson who circulated the petition sheets "Chief Sponsor Petition for Independent Nomination for President/Vice President Signature Sheet," the mark I made on the line for circulator signature on each sheet is my usual mark for indicating my signature, and that signature was meant at the time to attest to the facts:

(a) I believed the electors to be registered voters as they stated to me in response to my inquiry, and

(b) further that each elector on that petition sheet signed in my presence, I further affirm this date that each elector did in fact sign in my presence.


2. I have reviewed a stack of copies of petition sheets I circulated and signed. I understand these sheets were rejected by the Secretary of State. Each of the rejected sheets that has my handwritten name has my signature. On each of the sheets I put at least my first initial and signed my last name. As shown on the attached exhibit my signature varies a little, but I generally use a distorted "J" with a line for my last name.

3. No one from the Secretary of State office told me my signature was a "problem" nor offered me a chance to provide examples or samples of my signature.

the documents long before this signature campaign.


