1. I am the Vice Presidential candidate as a stand in for Peter Cameo in the Nader/Kucera Campaign.

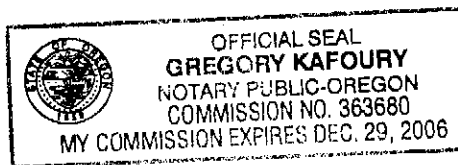
